

REVENUE GROWTH IN THE FIRST QUARTER OF 2025

Revenues during the period January–March 2025 nearly doubled compared to the same period in 2024, reflecting a significant enhancement in the Agency's financial performance.

Official data indicate that revenues for the first quarter of 2025 reached approximately 50 million ALL, up from 24.4 million ALL in the same period of the previous year.

Value of confiscated assets: **59,758,834 €**

LEASE CONTRACTS



During 2024, 282 lease agreements were signed, and an additional 93 contracts were signed in the first four months of 2025. This reflects the continued effective use of seized and confiscated assets.

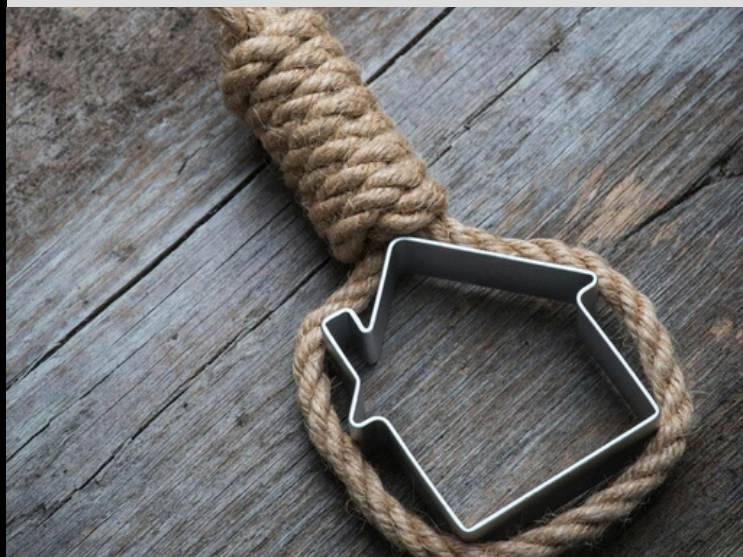

This is not merely a technical or administrative task — it is a mission in the service of justice and transparency.

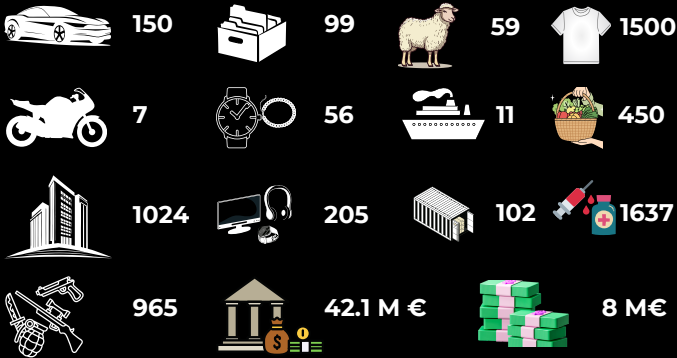
Our leadership is grounded not only in the application of law, but also in a forward-looking vision: to build a European model for the management of seized and confiscated assets.

Ke Buono – Fier



"Ke Buono" is a social pastry shop that operates in a confiscated property. It offers diverse products and inclusive activities for children, youth, and women, promoting community engagement, a culture of legality, and nonviolence.

My Artisan Tradition



A project promoting cultural heritage by employing women and girls from marginalized or rural areas in traditional crafts, fostering both empowerment and economic inclusion.

Art and Activism Center



In partnership with civil society, a confiscated property has been transformed into a cultural space for young artists and activists. The center hosts creative workshops, exhibitions, and awareness campaigns, empowering youth and marginalized groups. It is one of many ways AAPSK gives social value to confiscated assets.
